(i) Shall obtain final approval from the All India Council of Technical Education, Pharmacy Council of India and affiliation from Kerala University of Health Sciences, Thrissur for starting the course in 2017-18

(ii) Shall agree to admit students on 50% Merit and 50% Management basis. The merit seat students shall be admitted from the State Merit list prepared by the Commissioner for Entrance Examinations/Director of Medical Education and 50% seats by Management, at the rate of fee fixed by Government from time to time, subject to the other conditions in the Prospectus for each year.

(iii) Shall execute an Agreement with Government in the Health and Family Welfare (K) Department in terms of admission and fees.

(iv) Letter of Permission shall be withdrawn and fresh admissions shall be stopped by the State Government if the institution fail to create necessary facilities including infrastructure for the self financing Pharmacy College for conducting B. Pharm course as per AICTE, Pharmacy Council of India, Kerala University of Health Sciences and State Government norms.

(v) The institution shall indemnify loss if any sustained by the Government of Kerala on account of any liability of Government of Kerala to take over the responsibility of students already admitted in the College with the permission of the Government.
